Bee Disease Insurance (BDI) for Full & Partner Members: In accordance with our Constitution, all colonies must be insured with Bee Disease Insurance Limited. A colony is, any hive of bees regardless of size. Any potential increase in colony numbers between 1st January 2019 and 31st December 2019 must be taken into consideration. If found to be under insured YOUR CLAIM WILL BE INVALID. First 3 colonies are included your subscription. Details of the BDI insurance bands are given at the end of this form.

40-day rule. - BDI insurance becomes effective each year from the time that the member's association receives his or her membership subscription and any additional BDI premium is received. Premiums are paid in respect of the calendar year, 1st January to 31st December, irrespective of the date on which they are actually paid. However, cover will not commence until 40 days have elapsed from the payment of the premium, where such payment is made after 31st March. This is known as the 40-day rule.

Bee Disease Insurance BDI now have 8 bands for insuring hives:
